Sub: Implementation of reservation of 10% seats for the Economically Weaker Section (EWS) candidates by enhancing under graduate seats in the existing State/UT Government & Govt. Aided ASU Colleges/Institutes from the Academic Year 2019-20-reg.

Madam/Sir,

With reference to letter of Govt. of India, M/o AYUSH vide reference no. L.14011/5/2019(EP-1) dated 02.05.2019 and 24.06.2019 (copy enclosed) enclosing the office memorandum dated 17.01.2019 of the Department of Higher Education, Ministry of Human Resource Development on the subject cited above, with regard to implementation of reservation for EWS for admission to Under graduate course in Government & Govt. Aided ASU Colleges under the control of Central and State Government, I am to request you to send your proposal under the EWS Scheme in consultation with concerned Government & Govt. Aided institutions from the academic year 2019-20 not later than 26th June, 2019. In the proposal, the increase of 10% EWS quota should be on the seats that stand permitted on the day of submission of the proposal.

The proposals for increase of seats U/s 13A of the IMCC Act, 1970 (Regular Application process for Increase of Seats other than EWS) as envisaged under the Establishment of New Medical College, (Opening of New or Higher Course of Study or Training and increase of Admission Capacity by a Medical College) Regulation, 2003 (read with amended upto 2013) should be made separately.

The college-wise BAMS/BUMS/BSMS seats increase proposal to the Secretary, CCIM should reach the Council office not later than 26th June 2019 by e-mail (<u>secretary@ccimindia.org</u>) and/or by post.

You are further requested to furnish the seat increase matrix along with relevant information as per the enclosed format.

In this regard, please find enclosed herewith a "Guidance Note" to be followed along with the prescribed proforma as annexed for submission of application to CCIM at the earliest. The last date of submission is 26.06.2019 so that all the intending States/UTs may avail this opportunity for providing benefit of 10% EWS quota for students of their States/UTs and the recommendations of the council could be sent to Govt. of India by the 28.06.2019.
