Matter related to grant of conditional permission to the Government Gurukul Ayurvedic College, Gurukul Kangari, Haridwar, Uttarkhand with 60 seats in UG (BAMS) course Sub: and 12 seats in 05 PG courses namely (i) Kayachiktisa -03 seats, (ii) Shalya Tantra-02 seats (iii) Panchkarma- 03 seats, (iv) Shalakya - 02 seats, (v) Kaumarbhritya-02 seats under Section 13C/13A of the IMCC Act, 1970 for the academic session 2018-19 -reg.

I am directed to refer to the Ministry's order No. R.17011/191/2017-EP(IM-1) for 2018-19 Sir. dated 25.08.2017 related to admission matter for the year 2017-18 intimating certain shortcomings for rectification for consideration of the case for the academic session 2018-19.

- The CCIM had carried out an inspection of the institution on 18-19.05.2018 to reassess the available facilities of teaching and practical training as well as to verify the compliance submitted by the college and forwarded its recommendations and report to the Ministry. On examining in terms of the "Indian Medicine Central Council (Requirements of Minimum Standard of Ayurveda Colleges and attached Hospitals) Regulations, 2016", provisions under the IMCC Act, 1970, relevant regulations several deficiencies were found. However, the CCIM has recommended for granting conditional permission for admission with60 seats in UG (BAMS) course and 12 seats in 05 PG courses namely (i) Kayachiktisa -03 seats, (ii) Shalya Tantra-02 seats (iii) Panchkarma- 03 seats, (iv) Shalakya - 02 seats, (v) Kaumarbhritya-02 seats for the academic session 2018-19 subject to furnishing of undertaking from Secretary/Director/Commissioner of the Department of AYUSH/ISM of the State Government with an assurance that they will remove the shortcomings within three months.
- After receiving of undertaking vide Letter No-/050/xxxx/2018-17/2012 dated 16.07.2018, & DO No.1050/2018 dated 16.07.2018 submitted by the Secretary, AYUSH & AYUSH Education Department, Govt. Of Uttarakhand to the Ministry of AYUSH, New Delhi. It has, therefore, been decided to grant conditional permission to the Government Gurukul Ayurvedic College, Gurukul Kangari, Haridwar, Uttarkhand with 60 seats in UG (BAMS) course and 12 seats in Riels Tikey

- There are Asst. Matron, X-Ray technician, peon, worker, analytical chemist, biochemist, pharmacologist not available against the requirement of 02, 01, 01, 02, 01, 01, 01 each. iv.
- lifter in Rachana sharir, museum keeper in swasthyavritta and yoga, laboratory assistant in Shalya dept. are not available against the requirement of 01,01, 01 as per RMS.
- There are Animal house & Central research laboratory not available as per RMS. vi. vii.
- In Central Library, Area and seating capacity not available as per RMS. viii.
- There are Operation Theatre not available as per MSR. ix.
- There are Clinical Laboratory, X-Ray, ECG and USG are not available as per RMS.
- There are Biometric attendance is not available as per RMS. xi.
- The College is also directed that the following requirements should be fulfilled by the college positively by the 31st December, 2018, which will be verified for granting permission from the
- all the Requirements of Minimum Standard of infrastructure and teaching & training academic session 2019-2020 onwards: facilities as specified in Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016 by 31st December 2018 to get conditional permission.
 - (ii) all the requirements of the Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) Amendment Regulations, 2016 (for Ayurveda);
 - (iii) all the requirements of the Indian Medicine Central Council (Post Graduate Ayurveda
 - (iv) all the requirements under the provisions of the IMCC Act, 1970 and relevant Regulations made thereunder should be fulfilled in toto.
 - The fulfillment of the conditions attached to the permission given above may be made within the time period specified and compliance report should be submitted to the Ministry of AYUSH endorsing a copy to the CCIM also. The CCIM will verify by means of an inspection that the conditions have been fulfilled and submit a report in this matter to the Ministry of AYUSH for considering the permission matter from the session 2019-20.
