I am directed to inform all ASU institutions that the **Elective Classes for the 3rd Professional year** of undergraduate courses are scheduled to commence from **16th July 2025**.

### Important Dates:

- **Promotion Portal Window (for colleges) :** 7th July 2025 to 21st July 2025
- **Course Payment Window (for students):** 16th July 2025 to 15th August 2025
- **Course Completion and Generation of Result :** After 30th June 2026

### Course Enrollment Criteria:

**Case1:** Students who have **not enrolled in I and II Professional Courses** will be required to pursue a **minimum of 9 courses** (three from each section) in the III Professional Course.

**Case2:** Students who have **not enrolled in the Second Professional Elective Course** will be required to pursue a **minimum of 6 courses** (two from each section) in the Third Professional Course.

**Case3:** Students who are **enrolled in both I and II Professional Courses** will be required to pursue a **minimum of 3 and maximum of 5 courses** (one from each section) in the III Professional Course.

### Note:

1. Students can select electives from all Professional levels under the 3rd Professional Elective list. This is the final opportunity for them to complete the required nine electives to be eligible for the Final Professional University Examination.
2. In Case, if a student does not qualify the minimum THREE ELECTIVES courses during the respective professional session but qualified during the later professional sessions, the marks of those electives shall not be added to the viva marks of the respective subjects.
